PREVENT DISCONNECT

Thank you for being a valued customer. Please be aware that all charges must be paid each month to keep your account current and prevent collection activities. We are required to inform you that certain charges **MUST** be paid in order to prevent interruption of basic local service. These charges are already included in the Total Amount Due and are \$25.49. Also, neglecting to pay for remaining charges may result in interruption or removal of these remaining services or further collection action.

CARRIER INFORMATION

Our records show that you have not selected a primary local toll or long distance carrier. Please contact us if this does not agree with your records.

ELECTRONIC PAYMENTS

When making a secure electronic bill payment from your bank account over the phone, you will need to provide sufficient information to authenticate yourself as the account owner. By providing this information, you are authorizing AT&T and your financial institution to process a one-time debit from your bank account for payment of your bill. Other bill payment options are available at www.att.com

AT&T LD WEB NOTICES

Beginning 01/01/2011, price increase notices for various services will be provided by web only, at att.com/s-increasenotices, namely: 1) intrastate/interstate/international TRANSACTION-BASED SERVICES (e.g., Operator/ Directory Services, Public Payphone Surcharge, calling /credit card calls), and INTERNATIONAL MOBILE TERMINATION CHARGES, which will be posted 30 days in advance; and 2) interstate and international Federal Universal Service Fund Charge (a DISCRETIONARY FEE that may change quarterly), which will be posted at least 3 days in advance. FUSF/SLC BILL ERROR

The Subscriber Line Charge (SLC) and the Federal Universal Service Fee (FUSF) were under billed on your account. While we are not collecting for past under billing, we will begin charging the correct amount by 11/1/2010. Around this date, you may see a \$0.13 increase on your bill for the SLC and a corresponding increase in the FUSF on each additional access line that was under billed.
